Membership conditions

- 2. Membership is valid for one calendar year (January-December). We calculate the membership fee pro rata starting from the date of joining.

- 4. Membership cancellation must be requested in writing before the end of December. After December, membership will automatically be renewed for one year and the membership fee must be paid.
- 5. MEDVIA does not store personal data longer than necessary for the purposes for listed. The data you provide us can be shared with third parties if it is necessary for the functioning of MEDVIA in the framework of legitimate interests (e.g. reporting to grant authorities) and can be used for communication and marketing.
